For the 2017-18 year, schools were identified using new definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that has at least one underperforming student subgroup. An Additional Targeted Support (ATS) school is one that has three or more underperforming student subgroups. A Comprehensive Support and Improvement (CSI) school is one whose performance is in the lowest 5% of all schools in the state. Some schools are not identified with any of these labels. In these cases, no label is given.

Our Jr./Sr High School has not been given one of these labels.

Though the Jr./Sr. High School was not given a label last year we continue to try to make improvements in student achievement. Our SAT and MStep scores were below average. We are using technology to help improve scores, especially those in science. Our increased technology initiatives will help all of our students have access to information and resources that would not have been available in the past.

Akron-Fairgrove Jr./Sr. High School continues to work to overcome funding challenges and previous teacher reductions. We are continuing to find ways to improve student achievement for all students in the district. Some of the initiatives that we are enacting this year include the addition of paraprofessional staff to help struggling students and a larger intervention program.

- All students in the Akron-Fairgrove District have the opportunity to attend Akron-Fairgrove Jr./Sr. High School for grades 6 through 12.
- Students in those grades are served through a continuous School
  Improvement Plan that targets student achievement in the areas of English
  Language Arts, Mathematics, Writing, and Behavior. School Improvement
  goals are evaluated annually and progress is determined based on student
  achievement data through state assessments or local assessments
  administered by our teaching staff.
- There is no specialized school located within the high school.
- The curriculum is guided by and aligned to the Common Core Curriculum. It is implemented through classrooms in grades 6-12. The curriculum coincides with the State standards and curriculum. Teachers at Akron-Fairgrove High School are highly qualified within the core content area that they teach. Use of "research supported" and/or "best practice" instructional strategies is a priority for our teachers. Participation in professional development activities and frequent collaboration with other teachers provides opportunity for staff to explore and implement effective instructional strategies in the classroom.
- In the spring all juniors were assessed MStep and SAT. In the Spring of 2018, our 6<sup>th</sup>, 7<sup>th</sup> and 8<sup>th</sup> grade students were assessed using the MStep. Our accountability status for each subject area was 'green'.

We offer time for parents to communicate with teachers daily, email accessability and a web-based program (Powerschool) through which parents can view their students' grades. We offer Parent-Teacher Conferences in the

- fall and spring of each school year. In 2016-2017, our parent participation in Parent-Teacher Conferences averaged 70%. In 2017-2018 our parent participation in Parent-Teacher Conferences averaged 71%.
- In 2016-2017, there were 3 students taking Dual Enrollment courses, which represent 4% of our population. In 2017-2018, there were 4 students taking Dual Enrolment courses which represents 6% of our student population. In 2016-2017 there was one AP courses offered. 12 Students took those courses which represent 16% of our population. In 2017-2018, there was one AP course offered. 10 students took that course which represents 14% of our population. No students took the AP test.

All schools have challenges. We were proficient in 4th grade ELA. We are evaluating current effective learning strategies, assessments and research-based interventions to meet the needs of all students.

State law requires that we also report additional information.

- 1. Since there is only one elementary school within our district, all elementary students are assigned to the same school. All students in the Akron-Fairgrove District have the opportunity to attend Akron-Fairgrove Elementary School for grades K-5.
- 2. Students in those grades are served through a continuous School Improvement Plan that targets student achievement in the areas of English Language Arts, Mathematics, Science, Social Studies and Behavior. School Improvement goals are evaluated annually by school improvement stakeholders. Progress is determined based on student achievement data through state assessments or through standardized assessments administered.
- 3. There is no specialized school located within the elementary school.
- 4. The curriculum is guided by and aligned to the Common Core Curriculum. It is implemented through grade level classrooms and the Title I program in grades K-5. The curriculum coincides with the State standards and curriculum. Teachers at Akron-Fairgrove Elementary School are highly qualified within the core content area that they teach. Use of "research supported" and/or "best practice" instructional strategies is a priority for our teachers. Participation in professional development activities and frequent collaboration with other teachers provides opportunity for staff to explore and implement effective instructional strategies in the classroom.
- 5. In the fall of 2018, all elementary students were assessed using the DIBELS Next assessment for Reading and DIBELS Math for Math. Students in  $3^{\text{rd}}$ - $5^{\text{th}}$  were assessed with the M-STEP.
